**SUBMISSION OF SAFETY MEASURE BEFORE THE START OF ANY
CONSTRUCTION, RENOVATION, AND DEMOLITION OF
BUILDINGS OR ANY STRUCTURE WITHIN SCHOOL
PREMISES**

Chief, Curriculum Implementation Division

Education Program Supervisors
All Public and Secondary School Heads

1. By virtue of **DepEd Order No. 37, s. of 2015**, it is the mandate of this Office to ensure that all schools implement and comply with the safety standards required before the start of any construction, renovation, and demolition of buildings and other similar structures within the school premises.
2. In compliance to this, all schools are required to prepare and submit to this Office, through the DRRM Unit of the School Governance Operation Division (SGOD), a **Risk Reduction Management and Safety Plan (RRMSP)** a week before any activity relative to construction, renovation, and demolition in schools shall commence.
3. In preparing and adopting a school RRMSP, the standards prescribed in the School DRRM Manual and the School Safety Monitoring tool used during Brigada Eskwela shall be considered such as, but not limited to the following:
 - ✓ provision of warning signage for any ongoing construction, renovation, and demolition of buildings;
 - ✓ proper storage and safe keeping of construction materials
 - ✓ immediate disposal of construction debris and industrial waste
 - ✓ conduct of immediate clearing and cleaning operations

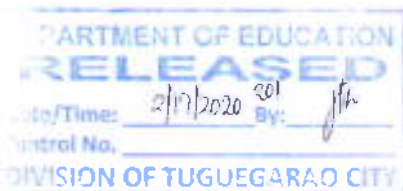
