SUBMISSION OF Learning Modality Plan (LMP), Updated Learning Continuity Plan(LCP), Conduct of Pilot Test of All Other Schools



 - 1.1 Organize a Special Committee to prepare the Learning Modality Plan (Class Program)
 - 1.2 Submit to this office the Learning Modality Plan (Class Program) of all classes per grade level for review and approval on or before August5, 2020
 - 1.3 Submit to this office the updated school's Learning Continuity Plan with the preferred learning modality and the strategies for the implementation of such on or before August 5, 2020.
- All other schools shall conduct Pilot Testing of their chosen modality on August 3-7, 2020 following their Learning Management Plan for week 1 in a sample class in 1 grade level of a chosen learning area. Please coordinate with the Division LR Supervisor for the soft copy of the SLM to be used.
- Schools shall submit to this office on or before August 10, 2020 an accomplishment report of the conducted pilot test following the template in Enclosure 2 of Regional Memo. #053, s. 2020 with pictorials.






