1. Pursuant to Proclamation No. 1906, s. 2009, declaring October of every year as the National Indigenous Peoples Month and the Department of Education recognizing the presidential proclamation through its issuance of DepEd Order No. 148, s. 2016 - Observance of the National Indigenous Peoples with the theme **“Hamon ng Pandemya ay Harapin, Gabay ang Katutubong Karunungan at Giting”**, the Division of Tuguegarao City will hold a virtual culminating activity titled **“Dayaw na Ibanag anna Itawes Festival”** on November 13, 2020.
2. In view of the forthcoming celebration, the four (4) districts namely, North District, East District, West District, and Northeast District) shall choose their participants from their respective schools (either from Kindergarten, Elementary, Junior High and Senior High) to represent their district in the different contested categories. The announcement of winners will be on November 13, 2020 to culminate the IP month celebration. The top three scorers in all contested categories shall be declared as winners.
3. The different contested categories shall be video recorded and submitted on a google drive on November 11, 2020 for the judges to review. The link of the drive will be sent before November 11, 2020.
4. Attached are the guidelines and mechanics of the different contested categories and the official piece for the poem and story retelling competition.

GUIDELINES AND MECHANICS

I. Poem

1. The contest is open to all Kindergarten to Grade III Ibanag and Itawes pupils. The contested piece entitled Pammakakua (Ibanag and Itawes versions) shall be sent to the schools through the IPEd Focal Persons.
2. The piece shall be delivered either in Ibanag or Itawes.
3. Each district will have only one contestant to the division level competition.
4. The criteria for judging are as follows:
 - a. Expression -10 %
 - b. Enunciation -20 %
 - c. Phrasing and Juncture -20 %
 - d. Fluency -20 %
 - e. Accuracy -20 %
 - f. Poise and Composure -10 %
5. The decision of the board of judges is final and irrevocable.

II. Vocal Solo

1. The contest is open to all elementary and secondary Ibanag and Itawes students.
2. There should be two contestants per district (elementary/secondary).
3. The contestant can sing any Ibanag or Itawes song using either a minus one or accompaniment.
4. Each district will have only one contestant to the division level competition.
5. The criteria for judging are as follows:
 - a. Voice Quality - 30 %
 - b. Pronunciation - 15 %
 - c. Timing - 15 %
 - d. Stage Presence - 15 %
 - e. Mastery of Lyrics - 15 %
 - f. Audience Impact - 10 %
6. The decision of the board of judges is final and irrevocable.

1. The contest is open to all Ibanag and Itawes elementary and secondary school teachers.
2. The contestants can sing any Ibanag or Itawes song using either a minus one or accompaniment.
3. The criteria for judging are as follows:
 - a. Voice Quality - 30 %
 - b. Pronunciation - 15 %
 - c. Timing - 15 %
 - d. Stage Presence - 15 %
 - e. Mastery of Lyrics - 15 %
 - f. Audience Impact - 10 %
4. The decision of the board of judges is final and irrevocable.

IV. Balse Ibanag Folk Dance

1. The contest is open to all Ibanag and Itawes elementary and secondary school teachers.
2. Each participating group shall form a minimum of 3 pairs.
3. The official dance piece shall be sent to the schools through the IPed Focal Persons.
4. The criteria for judging are as follows:
 - a. Choreography (Creativity, Artistry, Style & Originality) -30 %
 - b. Execution (Timing, Coordination, Projection & Expression) -30 %
 - c. Costume -20 %
 - d. Audience Impact -20 %
5. The decision of the board of judges is final and irrevocable.

V. Mascota Dance

1. The contest is open to all Ibanag and Itawes elementary and secondary school teachers.
2. Each participating group shall form one pair.
3. The official dance piece shall be provided by the participating groups.
4. The criteria for judging are as follows:
 - a. Choreography (Creativity, Artistry, Style & Originality) -30 %
 - b. Execution (Timing, Coordination, Projection & Expression) -30 %
 - c. Costume -20 %
 - d. Audience Impact -20 %
5. The decision of the board of judges is final and irrevocable.

 - b. Expression -20 %
 - c. Enunciation -20 %
 - d. Content and Depth -20 %
 - e. Audience Impact -10 %
