CONDUCT OF MONITORING OF THE IMPLEMENTATION OF SCHOOL-BASED FEEDING PROGRAM – MILK FEEDING PROGRAM COMPONENT, SCHOOL DENTAL HEALTH CARE PROGRAM AND INTEGRATED SCHOOL NUTRITION MODEL PROGRAM

1. For the school-based feeding program, the coordinators are advised to prepare for the delivery, distribution of commodities and interview with the parents' recipients following the minimum health protocol.



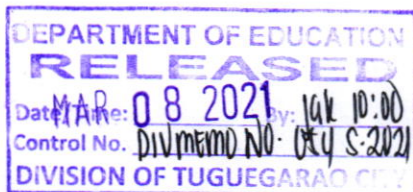
