will be an opportunity for the concerned schools to benchmark from the experiences and practices of the schools with SBM Level III practice.

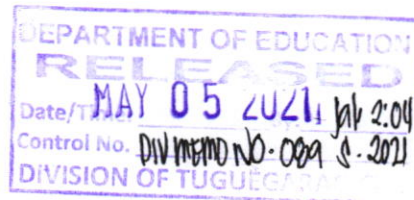
5. Division Personnel and Officials are likewise encouraged to watch the said undertaking.
