- b. Personal Data Sheet (CS Form No. 212, Revised 2017), fully accomplished and duly subscribed with recent passport-sized picture and Work Experience Sheet. The format and/or copy of which can be downloaded at www.csc.gov.ph;
- c. Performance Ratings for the last three (3) rating periods, from current/previous employer (S.Y. 2020-2021 as the latest), if any;
- d. Updated Service Record/s and/or Certificate/s of Employment from current/previous employer/s, if any;
- e. Transcript of Records (TOR) Bachelor's Degree and Post Graduate Studies, if any;
- f. Certificate/s of Eligibility/ Rating/ License, if any;
- g. Certificates of Participation to relevant trainings/ seminars attended with supporting documents (such as travel order and legal basis for the travel) and not credited during the last promotion, if any;
