**REITERATION ON THE STRICT COMPLIANCE TO THE GUIDELINES ON THE
REQUIRED HEALTH AND STANDARDS IN THE BASIC EDUCATION OFFICES
AND SCHOOLS**

1. On June 25, 2020, the Department of Education released the DepEd Order No. 14, s 2020, entitled **Guidelines on the Required Health and Standards in the Basic Education Offices and Schools**, which requires among others, that all public and private elementary and secondary schools to adopt guidelines and other interventions as mitigating measures against COVID 19.
2. In compliance to the above mentioned DepEd Order, all public schools are required to observe the following guidelines in accommodating request for the use of school or any of its facilities for any undertaking such as, testing or examination venue, events place, meeting or assembly or for any other similar activities:
 - a. The prior approval of the Schools Division Superintendent or his duly authorized representative must be sought before the request be granted by the school;
 - b. The requesting party should ensure the health and safety of school personnel who are requested to be present or to assists/serve during the conduct of the activity;
 - c. The requesting party should also ensure the maintenance of the cleanliness/orderliness/sanitation of the school during and after the activity;
 - d. Massive disinfection of the entire school premises, including classrooms, and other facilities and equipment, should be the responsibility of the requesting party, and it should be done within the day immediately after the activity;

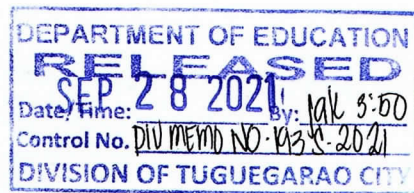
