

- 2. All examinees must undergo Antigen Testing. Antigen Test Result must be presented to the Medical Team upon registration. Test Result shall only be valid for 24 hours. It is therefore advised that testing be done a day prior to testing day.
- 3. Expenses incurred for Information and Communication Technology (ICT), medical expenses for Antigen and all other incidental expenses for all SDO personnel involved in the above-mentioned examination shall be shouldered by Schools Division Office, subject to the usual accounting and auditing procedures. Service credit/s shall also be given, as the case may warrant.
- 4. Provision for transportation must be readily available (DRR Rescue, ambulance) in case where an examinee/s or SDO personnel manifest symptoms of Covid 19, to be ferried to the nearest Health Care Facility for further medical evaluation.
- 5. All other provisions of the afore-said Memorandum are still enforced.
