CONDUCT OF NATIONAL ASSESSMENTS (EARLY LANGUAGE AND LITERACY AND NUMERACY ASSESSMENT, NATIONAL ACHIEVEMENT TEST GRADE 6, NATIONAL ACHIEVEMENT TEST GRADE 12)

- 1. This Office was in receipt of an Unnumbered Department Memorandum and Advisory from the Bureau of Education Assessment-Education Assessment Division (BEA-EAD) announcing that SDO Tuguegarao City is sampled for the conduct of Early Language Literacy and Numeracy Assessment, National Achievement Test Grade 6 and Grade 12.

For ELLNA and NAT Grade 6, the number of test takers shall be dependent on the number of learners participating in the face to face classes and upon determination of the number of test booklets/answer sheets available.
- 5. Test Administrators for ELLNA and NATG6 are Grade 3 advisers and Grade 6 advisers respectively, external to the school. They shall be identified after determination of the number of sampled classes and participating learners (a separate Memorandum shall be issued to this effect), while Test Administrators for NATG12 are teachers with high knowledge on information technology.


