1. Relative to Division Memorandum No. 158, s. 2022 titled "2022 Pammarayaw Awards for Teachers", this Office issues the following additional guidelines/criteria:

Most Outstanding Kindergarten Teacher Category

- Must be a Kindergarten teacher for three (3) years; and,
- Must not be a winner of the same category in the previous Search.

Most Outstanding Teacher-Adviser Category (Elementary & Secondary)

- Must be a teacher-adviser of any school club/organization for at least one (1) year; and,
- Must not be a winner of the same category in the previous Search.

Most Outstanding ICT Coordinator Category (Elementary & Secondary)

- Must be an ICT Coordinator at present and served for at least two (2) years before the nomination; and,
- Must not be a winner of the same category in the previous Search.

Best School Research Management Practice Category Most Outstanding Teaching Researcher Category Most Outstanding Non-Teaching Researcher Category

Most Outstanding Member of the Division Research Technical Team Category

- Previous regional grand winners of individual categories are not qualified to participate.
- Members of the RRTWG are not eligible to join the Most Outstanding Non-Teaching Researcher and Teaching Researcher categories


