
1. In compliance with Regional Memorandum 023, s. 2023, this Office, through the Curriculum Implementation Division and Learning Resource Management Section, shall conduct the harvesting of available learning resources in the following programs: SPA, SPS, STE, SPED, Multigrade, IPED, Kindergarten, MTB, MAPEH, and Mathematics.
2. The activity aims to:
 - a. harvest learning resources that are available in schools and in the Schools Division Office to be quality assured in the Regional Office in support of the delivery of instruction in special programs; and
 - b. make the quality assured LRs available to teachers and learners through the Project IMMERSE of the Region.
3. Relative to this, the schools are requested to submit available learning resources in the specified programs for further quality assurance at the regional level. These resources should include the following:
 - a. school-indorsed LRs that were quality assured by the Division Quality Assurance Team, acknowledged for completion, and given certificates of conformance; and
 - b. LRs quality assured in the school level that are for possible endorsement to the division office for further quality assurance.
4. For item 3.b, certification that the LRs have undergone quality assurance from the School Quality Assurance Team should be attached.

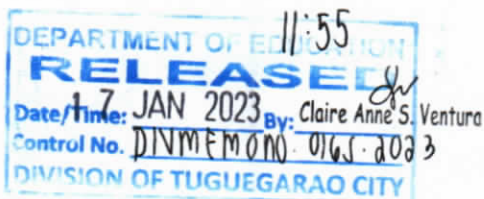
5. In addition, accomplished metadata form must be attached to each submitted learning resource for cataloging and uploading purposes.
